

Prerogative Court of Canterbury and related Probate Jurisdictions: Will Registers,
PROB 11/397/212.

Abstract of the Will of Sir John Borlase of Bockmore in the Parish of Medmenham in the County of Bucks, Baronet, written 7 Jan 1683/4, proved 8 Nov 1689.

Wills that his body be buried in the Chancel of the parish church of Stratton Audley in co. Oxon, where **his brother Baldwin** was interred.

Gives £1,500 to **Nicholas son of his brother-in-law S^r Humphry Miller** of Oxenhoath in co. Kent, Baronet, to be paid to him when he turns twenty-one.

Gives £1,500 to **Borlase**, another **son of S^r Humphry Miller**, to be paid to him when he turns twenty-one.

Gives £1,500 to **Elizabeth daughter of Sir Humphry Miller**, to be paid to her when she turns eighteen.

Gives £1,500 to **Mary**, another **daughter of Sir Humphry Miller**, to be paid to her when she turns eighteen.

Gives £1,500 to **Frances daughter of his brother-in-law Joseph Langton** of Newton Parke in co. Somerset, Esq^r, to be paid to her when she turns eighteen.

Gives £1,500 to **Dorothea**, another **daughter of Joseph Langton**, to be paid to her when she turns eighteen.

Gives £1,500 to **Henry son of the said Joseph Langton**, to be paid to him when he turns twenty-one.

Gives £1,500 to **Mary**, another **daughter of Joseph Langton**, to be paid to her when she turns eighteen.

Gives £1,500 to **Anne**, another **daughter of Joseph Langton**, to be paid to her when she turns eighteen.

Gives £1,500 to **John the son of his brother-in-law John Webb** of Peterley in co. Bucks, Esq^r, to be paid to him when he turns twenty-one.

Gives £1,500 to **Borlase son of his brother-in-law Arthur Warren** of Stapleford Hall in co. Nottingham, Esq^r, to be paid to him when he turns twenty-one.

Gives £1,500 to **Arthur**, another **son of Arthur Warren**, to be paid to him when he turns twenty-one.

Names **his sister Mary** as the **former wife of his brother-in-law S^r Humphry Miller**.

Gives £100 to **his sister Frances the wife of Joseph Langton**, to buy herself a ring.

Gives £100 to **his sister Anne the wife of Arthur Warren**, to buy herself a ring.

Gives £200 each to **his brothers-in-law S^r Humphrey Miller , Joseph Langton** and **John Webb**, to buy themselves each a ring.

Gives £100 to **his aunt Joane Borlase** of Great Marlow in co. Bucks, **widow**, to buy herself a ring. He also gives £100 each to **her daughters Mary Borlase, Anne the wife of Thomas Wingfield, Esqr, and Alicia the wife of Mr. Wallop.**

Gives £100 each to his friends John, Lord Lovelace, Baron, and Richard Kent of Broadstreet, London, to buy themselves rings.

Gives £100 to **his goddaughter Mary the daughter of John Green** of Millend in the parish of Hambledon in co. Bucks, Esq^r, to be paid to her when she turns eighteen. He gives £5 each to John Green and his wife Mary Green to buy themselves rings.

Gives £20 each to the poor of the parishes of Medmenham, Ludgarshall als. Lurgarshall, and High Wycombe, all in co. Bucks.

Gives £20 to the poor of Stratton Audley in co. Oxon.

Gives £20 each to his servants.

Gives £20 to George Woodward of Stratton Audley to buy himself mourning.

Gives £5 to William Whitlock of Henley-upon-Thames in co. Oxon, Gent., to buy himself a ring.

Gives £5 to Peter Dickinson? of Medmenham, Gent. to buy him a ring.

Gives £5 to Sr Edward Norris of Weston on the Greene to buy himself a ring.

Gives £5 to Francis Drake of Stoke in co. Oxon, Esq^r to buy himself a ring.

Gives £5 to his servant Elizabeth the wife of Henry Cane of Hillingdon in co. Middlesex, Gent. to buy herself a ring. Also gives £5 to Henry's son, Henry Cane, to buy himself a ring.

Gives £20 to **his cousin Thomas Wingfield** to buy himself mourning.

Gives an annuity of £100 to **George Borlase** of the City of London, merchant.

Gives annuities of £40 each to Henry Cane Sen^r of Hillingdon, gent. and to Mathew Cane of the City of London, his son.

Gives an annuity of £30 to his servant William Barton and Joane his wife.

Gives annuities of £20 each to his servants John Corker of Little Marlow in co. Bucks, Gabriel Page Sen^r of Bockmer in co. Bucks, Clemence Herroe (Herrot?) of Stratton Audley, and George Barton.

Gives annuities of £10 each to his servants Mary May, widow, John Norcott, Thomas Moody and George Spigurnell.

All the rest of his goods &c. he gives to **his brother-in-law Arthur Warren**, appointing him sole executor of his last will and testament.
