

*Abstract of the Will of John Harvey late of Trevore but now of the Town of Penzance  
in the County of Cornwall, Gentleman, written 10 Mar 1762, proved 11 Mar 1765.*

His body to be buried in the vault in the parish church of St. Buryan with the rest of his family.

Gives an annuity of £25 to **his wife Elizabeth**, payable out of his lands in Trevore in Buryan.

Gives to James Dunn of the parish of Redruth in co. Cornwall, Gentleman, **Elizabeth Harvey his wife, his daughter Jenney and her husband John Pender the Younger, and his daughter Elizabeth Harvey**, his messuages, lands and tenements called Polza the parish of Jacobstow, his messuages and lands called South Bean in the parish of Boyton, his messuages and lands called Biscovey in the parish of St. Blazey, his messuages and lands called Polmeor in the parish of Zennor, his messuages and lands in Sellan, in Ennesleven? and Banquitho in the parish of Creed, his messuages and lands in Newlyn in the parish of Paul, and his messuages and lands in Market Jew Street in the town of Penzance, to hold in trust, for the benefit of **his two daughters Elizabeth and Mary**, paying them £300 each, **his daughter Jenney** having already received her portion. If the amount raised from the sale of the above does not cover his debts and these legacies, he directs his executors to sell his messuages and lands in Bovetownes in the parish of Egloshayle.

Wills that his tin bounds in the parishes of Redruth, Gwennap, Illogan, St. Agnes and St. Just in Penwith not be sold, giving them and their profits to **his son John**, as well as his original aditt adventures and tributes in St. Just in Penwith.

He gives the profits of his tin bounds, tin adventures and tributes, to his three daughters, share and share alike for seven years after his death.

Wills that his dairies at Trevore be carried on and improved.

Gives to his said trustees his messuages and lands called Trevore, Banns and Tredinny, all in Buryan, his messuages and lands called Dowran and Trevedra in St. Just in Penwith, his messuages and lands called Kenowe and Carnelloe in Zennor, and his messuages and lands called St. Elvan and Torlevan in the parish of Sithney, to hold in trust, for raising and paying out the rents, issues and profits, the annuity of £25 to his wife, an annuity of £50 to **his son John Harvey** for life.

Appoints his said trustees co-executors of his last will and testament.

John Harvey married twice, first in 1722 to Alice Hoblyn in Sennen (just under 4 miles west of Buryan), and secondly to Elizabeth Vibert in Gulval in 1739.

John Harvey of Penzance, Gent. was buried in St. Buryan on 29 Dec 1764.
