

Prerogative Court of Canterbury and related Probate Jurisdictions: Will Registers, PROB 11/335/100.

*Abstract of the Will of Elizabeth Sone of London, Widow, written 18 Mar 1667/8, proved 21 Jan 1670/1.*

Gives and bequeaths £1600 to **her son John Child**, as well as her tapestry hangings, two featherbeds, two bolsters.

Gives and bequeaths £200 to **her son-in-law Richard Hutchinson, Esqr** for his tender care for **her daughter Anna Hutchinson** during her sickness.

Gives and bequeaths £300 to **her grandson Richard Hutchinson**.

Gives and bequeaths to **her grandson John Child son of her said son John Child**, all her farms and lands in Pricklewell? in county Essex. She directs that her grandson John Child shall pay £100 to **his brother Edmund Child**, when Edmund reaches the age of 21 years.

Gives and bequeaths £200 to her said grandchild Edmund Child, and £300 each to **Edmund's siblings Samuel Child and Anna Child**.

Gives and bequeaths £200 to **Martha Child, youngest daughter of her said son John Child**.

Gives to the said Anna Child her green curtains...

Gives and bequeaths £150 to **her grandson Richard Child son of her said son John Child**, and all her copyhold messuages lands tenements and hereditaments in the parish of Enfeild in county Middlesex.

Forgives to **her son Josiah Child** a debt of £100 which he owes on a bond dated 20 Oct 1652. She also forgives him a debt of £450 he owed her at Christmas last past.

Gives £300 to **her granddaughter Elizabeth Child daughter of her son Josiah Child**.

Gives to the wife of her son John Child her lesser diamond ring and to the wife of her son Josiah Child her other lesser diamond ring.

Gives to **her grandchild Elizabeth Hutchinson** her silver sugar box and her purple wrought curtains and vallente and the covers to the couch and stools thereto belonging.

Gives to **her grandchild Elizabeth Child** the best of her silver tankards.

Gives her linnen equally between **her granddaughters Anna, Mary and Elizabeth Hutchinson, and Anna and Elizabeth Child**.

Whereas she has lately purchased of Thomas Bromfeild, Esquire, and Lawrence Marsh Esquire a moiety of the manor of Sonwell Otwayes and Westbury in Ashwell and Kingworth in county Hertford, and in Edworth in county Bedford, which moiety

was bought in Trust for her son-in-law Richard Hutchinson, his daughters and their heirs.

Gives and bequeaths £300 each to the said Anna, Mary and Elizabeth Hutchinson.

Gives £50 to her son-in-law Richard Hutchinson and her son John Child to pay to **her cousin Anna Jennings the wife of Adam Jennings** for her own separate use.

Gives and bequeaths £50 to **Elizabeth the daughter of her cousin Anna Jennings**.

Gives and bequeaths £5 to be distributed among the poor of the parish of Stoke-upon-Trent in county Salop to be distributed at the advice of **her cousin Francis Rycroft** of Childe Arcoll?.

Gives and bequeaths £5 to the poor of the parish of Endfeild...

Gives £20 to **her cousin John Rycroft** who has lately come over from New England.

Gives £50 to the governess of Christ's Hospital London.

Gives 40 shillings to each of **her brothers and sisters children, Mr and Mrs Fenn, Mr and Mrs Peacock**, to buy each a ring in remembrance.

Nominates her son-in-law Richard Hutchinson as executor of her last will and testament.

In a codicil she gives £200 each to **Rebecka and Josiah Child, the two youngest children of her son Josiah Child**.
