

Prerogative Court of Canterbury and related Probate Jurisdictions: Will Registers, PROB 11/171/366.

*Abstract of the Will of Richard Tuffnayle, Citizen and Salter of London, written 4 Apr 1636, proved 17 Jun 1636.*

Gives, wills & devises to **his son Abraham Tuffnayle** and his heirs all his houses and tenements purchased of Richard Morgan gent. situate in Turnbull *alias* Turnemill Street and Conocrosse? in the parish of St. Sepulchre London, and also the lease interest and term of years he has in the house in which he now dwells as well as the two tenements adjoining it which he holds of St. Bartholomew Hospital London. Also one other lease of tenement situate in cattle yard in St. Sepulchre, now in the occupation of Thomas Willowes, citizen and tallow chandler of London. Also gives £200 to his said son Abraham.

Gives to **his son-in-law Robert Bowcher and to his daughter Anne Bowcher** all his household stuff currently in his dwelling house at Hadley in county Middlesex, except the copper and brewing vessels there. Also remits and releases to the said Robert Boucher such debts as Robert still owes him.

Gives to his said daughter Anne Boucher one of his broad silver bowls.

Gives & bequeaths £100 to **his grandchild Robert Boucher**.

Wills that **his son-in-law John Goddwyn** shall pay an obligation of £50 that both John and he are bound to one John Hog, citizen and brewer of London. Then he gives and bequeaths to **John's sons Thomas, Richard and James Goddwyn** £20 each. He gives to his daughter their mother Ann one of his white silver bowls.

Gives & bequeaths £50 to **his son Richard Tuffnayle**. He also gives to **his son's wife Elizabeth** one of his great gilt bowls.

Gives & bequeaths £50 to **his daughter Ellen Bentley**, as well as one of his broad gilt bowls, and to **her daughter Mrs. Ellen Graves** his second gilt salte.

Gives & bequeaths to **his son-in-law Alexander Nicholson** one wine bowl gilt.

Gives & bequeaths to his foresaid grandchild Robert Boucher two little beakers parcel gilt, his bell salt without a cover, and half a dozen silver spoons.

Gives & bequeaths to his son Abraham Tuffnayle his best gilt salt, one beer bowl, white, two beakers, parcel gilt, two wine cups gilt, and a dozen gilt spoons.

Gives & bequeaths to **his grandchild Richard Boucher** one silver wine cup.

Gives & bequeaths 20 shillings to the poor of St. Sepulchre-within-the-Barrs.

Gives & bequeaths £3 to the poor of the same parish without the Barrs.

Gives & bequeaths to **his brother Robert Tuffnayle** and to **John Tuffnayle Robert's son** such of his wearing apparel his executor deems fit.

Gives & bequeaths £5 to **his son-in-law Francis Zachary**.

Gives to his friend Mr. Richard Bates his gold ring with a toadstone in it.

Gives 20 shillings to his friend Noah Bankes.

Gives 20 shillings to Luce his late maidservant.

Gives & bequeaths to his six of **his grandchildren**, namely **Thomas, Richard and James Godwyn**, and to **Richard, Abraham and Anne Bowther**, one dozen, and a salt of silver, and gilt spoons.

Gives & bequeaths £10 to the governness of St. Bartholomew's Hospital in London.

Gives & bequeaths £10 to the Company of Salters in London.

Gives & bequeaths 20 shillings to his servant Christopher Tylliard.

Gives & bequeaths 20 shillings to his servant Sara.

All the rest and residue of his goods and chattels he gives & bequeaths to his son Abraham Tuffnayle, whom he makes and appoints sole executor of his last will and testament.

Nominates and appoints his son Richard Tuffnayle and **his son-in-law John Bentley** as overseers.
